#### **RULES AND REGULATIONS**

# (For admission into Non-Residential Sports Coaching Programme under the Mizoram State Sports Council)

- 1. Training will be provided for children below 17 years. Elite and promising athletes will also be provided training on need basis.
- 2. The applicants must be physically and mentally sound.
- 3. All applicants must be accompanied by a letter of permission and acceptance of all terms and conditions and rules and regulations laid down by the MSSC by the parents/guardians of all applicants.
- 4. The applicant should sign an undertaking to the effect that among others, the MSSC shall have no liability towards payment of compensation or claims for medical reimbursement in case of injuries sustained or loss of life during training.
- 5. The trainees must agree to bear all expenses for conveyance to and from the training centres which may be changed from time to time.
- 6. The trainees must provide for themselves all training gear and equipments.
- 7. The trainees must abide by all rules, instructions and directions of authorities during the programme. Any trainee not complying to such rules and instructions shall be dismissed from the coaching programme and may also be barred from admission to any other future trainings conducted by the MSSC. If any criminal offense is committed by any trainees, they shall be dealt with as per provisions established by existing laws.
- 8. A trainee shall be liable to be expelled from the programme for any case or cases of indiscipline or any case of inappropriate behaviour as defined by appropriate authorities.
