Terms of Reference:

1. The Board shall conduct its business in accordance with the principles laid down in the Mizoram Public Procurement Rules' 2020 and General Financial Rules 2017 as amended by Government from time to time, and any other relevant Rules in force.
2. The Mizoram State Sports Council Works Advisory Board shall consider bid responses received and evaluated by Bid Evaluation Committee for all works to be procured by the Mizoram State Sports Council costing Rs. 1 Crore and above.
3. The Bid Evaluation Committee shall be constituted by the Procuring Authority consisting of two or more officials headed by a responsible officer as it may deem fit. The Committee will analyze and scrutinize bids according to the evaluation criteria already incorporated in the bidding documents. The Bid Evaluation

Committee will scrutinize and evaluate the technical and financial bids responses for execution of works.

4. The Committee will submit its recommendations to the President, Mizoram State Sports Council for final approval.


