3. The Bid Evaluation Committee shall be constituted by the Procuring Authority consisting of two or more officials headed by a responsible officer as it may deem fit. The Committee will analyze and scrutinize bids according to the evaluation criteria already incorporated in the bidding documents. The Bid Evaluation Committee will Scrutinize and evaluate the technical and financial bids responses for procurement of goods or works or services.
