OFFICE MEMORANDUM

The Government of Mizoram adopted the General Financial Rules, 2017 vide No.G.25015/1/2018-F.APF, dated 01.05.2018 and as per Rule 175(1) of the General Financial Rules, 2017 no official of a procuring entity or a bidder shall act in contravention of the Code of Integrity. To ensure compliance of the Codes of Integrity outlined in Rule 175(1) of GFR, 2017, it has been considered necessary that all Bidders/Contractors should execute 'Integrity Declaration' in the form enclosed as Annexure.

All Procuring Departments must ensure inclusion of Integrity Declaration in the bidding documents for procurement of goods, works and services as per the Mizoram Public Procurement Rules, 2020, and only those bidders, who commit themselves to the Integrity Declaration with the Procuring Departments, shall participate in the bid process. Any bid not accompanied by the Integrity Declaration should be considered as non-responsive bid and should be rejected straightway and any violation of the Integrity Declaration would further entail disqualification of the bidders and exclusion from future business dealings. In case of bids by a consortium or a group of bidder, all representatives of such consortium or group should necessarily sign the Declaration.

All Administrative Heads/Head of Departments are informed to take notice of the content of this Office Memorandum and ensure that the Integrity Declaration is included in the bidding process for procurement of goods, works and services within their respective Department.
