3. MSSC-in thil tul atana Centre hi a hman duh a nih chuan thil dang aiin a lal zawk zel tur a ni a, a hman man pawh a chawi lo ang.
4. Management Committee hian Centre hman man (rate) hrang hrang a bituk ang a, MSSC pawmpuina a la hmasa thin ang.
5. Management Committee hian Centre hman dan a rel fel ang a, a enkawlina leh inrelbawlina senso (*kawlphehtha, tui leh bill dang awm thei bakah minor repair zawng zawng*) pawh sum a hmuh chhuah atangin a chingfel thin ang.
6. Management Committee hian a vawn himna leh vawn zahawmna kawngah neitu rilru puin tan a la reng ang a, englai pawha hman tlak ni turin hmun leh hma a vawng fai ang.
7. Centre chhiat theihna chi hrang hrang - kangmei, ruk ruk leh a dangte - laka venhimna mawh chu Management Committee in a phur ang.
8. Management Committee-in *register* fel tak siamin pawisa lut leh chhuak a vawng ang a, englai pawha dan anga enfiah theih turin tha takin a vawng ang.
9. Mizoram State Sports Council-in monthly/quarterly/half-yearly report a siam hmangin Management Committee sum hman dan chu District Sports Committee leh Mizoram State Sports Council hnenah a theh lut thin ang a, chu statement chu MSSC Annual Report-ah a remchan anga telh thin a ni ang.
10. Mizoram State Sports Council in a tul angin *inspection* a nei thin ang a, Management Committee-in tha takin a lo dawngsawngin a tawiawm thin ang.
